Early Childhood Caries Position Paper

Program Updates:

- **OSDH:** DLP program will be losing 3 dentists over the next few months. Will not be able to fill positions due to funding. Just hired a fluoride consultant, will be recognizing communities that are water fluoridation champions.
- **OK Dental Hygiene Assoc:** Annual session featuring Mary Otto on September 20. March Madness CE event March 29.
- **Delta Dental:** OU Kid's Day February 23rd
- **ODF:** Finalist for Impact OK grant. Mobile unit still reaching communities, 2019 calendar is filling up.
- **SPTHB/OKTEC:** Tribal Public Health Conference will be April 9-11th in Tulsa at the River Spirit Casino Resort.
- **OUCOD:** Interprofessional training at Good Shepherd with dental students and initiated Mother's Health Program with dental hygiene students, nursing, and nutrition students. Dr. Cumby, Community Division Chair will be retiring this year.

- **OKPCA:** Conducting annual salary survey for dental directors as well as dental roundtables to identify oral health needs at centers. Also looking into externships through the OUCOD and how they impact the longevity and sustainability of the health centers (i.e. Are they more likely to work for a FQHC after graduation?)
- **Head Start:** New fact sheet will be ready by next meeting, new data from the 2018 school year.
